

INVITATION TO BID

SEALED BIDS will be received until **10:00 AM, March 16,, 2006**, in the Director of Finance Office, 1330 Bayou Lane, Trailer No. 113, Slidell, La., thereafter opened in the Council Chambers and publicly read, for **City of Slidell, FY05/06 I/I PROGRAM SEWER REHABILITATION**.

Description

The scope of work for this project consists of the repair and/ or replacement of miscellaneous sewer lines located WITHIN the City of Slidell including installation of pipe, installation of services, and the replacement of roadways, driveways, curb and gutter, sidewalks, and other structures encountered.

The successful bidder will be required to furnish a Payment and Performance Bond in the amount equal to 100% of the bid amount.

Each bid must be accompanied by a Certified Check, Cashier's Check, or Bid Bond acceptable to the Owner in the amount equal to at least five percent (5%) of the bid amount. An executed affidavit shall be submitted by the low bidder prior to bid award.
